Our intent

In the context of growing systemic approaches to address some of the world's most complex challenges, we convened a Roundtable in November 2023, bringing together a select group of individuals we believe can contribute insights and expertise to help shape the foundational strategies and roadmap for the future delivery of multidisciplinary social veterinary services and the evolving role of veterinary social workers.

At Cherished Pets, our impact is evident in our daily interactions, testimonials, and the joy of happier people and pets. While our care model pets and people builds on existing frameworks, we recognise the need to take it a step further. This requires cross-sector ingenuity to transform how we support people and their pets.

Veterinary Social Work, a field that bridges human health and animal welfare, is gaining prominence as a powerful driver for positive change.

In the dynamic landscape we are working in, new services and organisations are addressing complex societal issues. These include the veterinary industry crisis, access to affordable pet care, the mental health crisis, domestic violence, homelessness, disability, and aging. As we address these multifaceted challenges, interest in the interconnecting of veterinary and social services continues to grow.

Our vision articulated at the time of the Roundtable, is a future where multidisciplinary social veterinary services and Veterinary Social Workers are integral components of our society.

By understanding the various interlocking system elements across animal welfare and human health and wellbeing, we can collaboratively problem-solve a solution.

This Roundtable is not just an event; it marks the start of a vital dialogue aimed at reshaping the veterinary landscape in Australia. Collectively, we explored pathways for training and employment for Veterinary Social Workers and multidisciplinary approaches to care services centered around the human-animal bond, seeking innovative solutions to address the intricate challenges that our society and veterinary profession face.

Together, we aim to unite voices across animal and human welfare sectors, forging partnerships, and working towards shared goals.

By tackling critical issues impacting both pets and people, we can create healthier, more inclusive communities.

Objectives

The purpose of the Roundtable was to explore the complex challenges that impact the veterinary industry and the wider pet community.

Our aim is to ignite positive transformation within our system creating a more inclusive future for pets, individuals, and veterinarians.

- Discover ways to strengthen the resources and access to systemic approaches for practitioners working on complex issues/problems/challenges linked to animal and human welfare.
- Identify our primary audiences and stakeholders for this initiative.

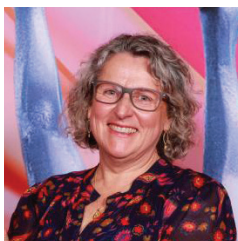


Who participated

Alicia (Lissi) Kennedy, is a Social Hearted Veterinarian and Founder of Cherished Pets, the world's first certified B Corporation veterinary service. She has led the development of an innovative ecosystem of pet and veterinary care with community at its heart, and accessible and affordable pet and veterinary care as its outcome. Alicia is a passionate advocate of the social value of vets, and the role of the human animal bond and healthy companion animals in human health and wellbeing and a thriving, connected society. She has a close association with Dr Jane Goodall as one of the founders of JGI-Australia.
